To be eligible to vote you must be all of the following:

- A U. S. Citizen
- At least 18 years old by Election Day
- •A resident of the Township for at least 30 days

You can request an Absent Voter Ballot Application at the Township Office or by printing a copy from our website <a href="www.ross-township.us">www.ross-township.us</a> under the Election tab. The Township maintains a permanent Absent Voter list which allows voters who are 60 years of age or older, or unable to vote without assistance, to receive an Absent Voter Application for each election. If you wish to be placed on the list, please contact the Township Clerk (269)731-4888. You may also verify your voter registration at <a href="www.michigan.gov/sos">www.michigan.gov/sos</a>. Voter Registration Applications are available by contacting the Ross Township Office.



# NEWSLETTER Spring 2017

#### From The Supervisor's Desk The Roads of Ross Township

As the weather changes the condition of our roads in Ross Township become a topic of conversation and decision making for your Township Board. Ross Township has approximately fifty miles of local roads which the Road Commission of Kalamazoo County (RCKC) is limited in funding road construction projects.

- Ross Township receives approximately \$65,000 from RCKC to put towards our local road construction projects annually.
- The Township can only receive this money if it provides a dollar for dollar match from our General Fund.
- The Township has approximately \$130,000 per year for local road construction projects.
- Presently, over twenty miles of these "local" roads in Ross Township are what the RCKC would consider in "poor" condition.
- The cost to reconstruct a mile of "poor" or "failed" road is approximately \$200,000 per mile.

So where does the money come from and what is the answer to fixing our local roads in Ross Township? Unfortunately, there is no answer other than the Residents of our Township. Across the State of Michigan this effort to rebuild and sustain the local road infrastructure has come from residents of Townships as a long term investment. This investment may come from special assessments, local millage, private sources or how we have in the past, from the Township General Fund. Roughly \$4 million is needed today for these "poor" local roads, which does not include the repairs of the other thirty miles of local roads in "good" and "fair" condition. Additional information on the condition of all roads in Ross Township can be found at the RCKC website Road Data page.

In the Summer of 2016, the Township formed a citizen's Road Committee to look at options for funding the repair of local roads. In December of 2016, the Road Committee recommended to the Township Board to establish a Township wide Special Assessment on each individual parcel owned in Ross Township to raise the money necessary to bring all the local roads in our Township back to "good" condition. This recommendation is currently under consideration by the Township Board and is being supported by the Ross-Augusta Fire Department, Gull Lake Community Schools, and LifeCare Ambulance. This funding approach is similar to what other surrounding Townships (Bedford (Calhoun County) Kalamazoo, Alamo, and Texas) have undertaken to invest in local road improvements in their Townships.

The Township Board will continue to discuss, solicit input from Residents, and "crunch" the numbers in order to determine a plan to improve the local road network. The Township is open to feedback and will communicate the status of the roads initiative as much as reasonably possible. We will be scheduling some Town Hall Meetings in the near future to present our findings and plan for the future of our roads.
